Unless the applicant's financial situation changes significantly, this information may be submitted once per academic year.

\_\_\_\_\_ **Olin P. Moyd Memorial Scholarship** Applicants must submit a letter of recommendation from a professor or pastor.

\_\_\_\_\_ **Partnership Scholarship** Applicants must submit a letter of financial commitment from the Partner (e.g., church) on official letterhead stating the award amount. The E.I. invoices the Partner, whose payment is due within 30 days of receipt.
