Procedure

1) Staff must be notified if reproductions will be requested. A document reproduction request form will be provided by the staff together with reproduction flags and instructions on how to identify material to be reproduced:

- Use a document reproduction flag to identify items to be copied.
- Use one document reproduction flag per item.
- Identify the item on the document reproduction flag (ex., document number or date of document)
- Note any special instructions on the document reproduction flag (ex., # of pages from the document to be reproduced). Document reproduction flags will be stapled to paper copies.
- Place the document reproduction flag in front of the item and sideways so that the flag is visible when the folder is returned to its box. Original material is **not to be removed** from the folder and the folder is not to be set outside the box.
- Indicate to staff which boxes contain document reproduction flags and which boxes can be re-shelved.

2) Reproductions from the collections of the three sponsoring institutions as well as rare books and images must be pre-approved by the director of the archives, who reserves the right to deny the reproduction of materials. The director also reserves the right to restrict the reproduction of entire series of records. Reproductions from books and newspapers that can be found elsewhere will not be performed by the staff.

3) Reproductions are available in two formats: paper and digital (documents as .pdf files and images as .jpeg or .tiff files). Please indicate format on the request form.

4) The amount of copying permitted is restricted by staff time and availability. Additional charges will be assessed for document reproduction jobs more than 50 pages. The maximum number of pages a researcher can request to be reproduced is 500. Completion of orders is based on staff time and availability.

Document Reproduction Costs and Billing

1a) On-site researchers: document reproduction is 25 cents per page. In addition, the following charges will apply to document reproduction jobs larger than 50 pages:

51-100: \$10.00	201-300: \$30.00	401-500: \$50.00
101-200: \$20.00	301-400: \$40.00	

1b) Off-site researchers: A document retrieval fee will be assessed in addition to the document reproduction fees detailed above:

Secondary Material & Newspapers on Microfilm: \$5.00

Primary Material: 1-19 pages, \$10.00; 20-39 pages, \$20.00; 40-59 pages, \$30.00; and so on

2) Cost of postage and handling is assumed by the requester.

3) Researcher will be notified by staff of the total charge when the request has been completed.
